**Visiting Scholar Application Procedure**

Scholars in music who wish to conduct independent research while in residence at the Jacobs School of Music may apply to be a Visiting Scholar. Visiting Scholars have the opportunity to work with a faculty member, use the facilities of the William and Gayle Cook Music Library, and take advantage of other musical and intellectual resources of the Indiana University Bloomington campus.

Visiting Scholars are typically faculty, post-graduate researchers, or doctoral candidates at institutions other than Indiana University. Visiting Scholar appointments in the Jacobs School are restricted to researchers with valid projects requiring their presence on the Bloomington campus and consultation with a Jacobs School faculty member. Visiting Scholars are not permitted to enroll in courses (including performance, conducting, and composition lessons), participate in ensembles,\* give scheduled recitals, nor are they permitted to teach. Only a limited number of Visiting Scholars are hosted by the Jacobs School in any given year.

Potential Visiting Scholars must first secure a faculty sponsor; the sponsor must be a Jacobs School of Music faculty member and should ordinarily have expertise in the area in which the applicant plans to do research. Applicants should not send a mass e-mail to multiple faculty, but rather identify the most appropriate faculty member based on their interests, and secure that faculty member's written agreement to serve as a sponsor before making an official application. The potential Visiting Scholar should include the faculty member's signed letter along with the other application materials.

How closely the Visiting Scholar works with the faculty sponsor should be worked out in advance, but the faculty sponsor should not be expected to provide assistance with personal matters, such as housing and transportation. Visiting Scholars are often welcome to participate in the professional life of their host department by attending colloquia and performances; the faculty sponsor can provide information on these opportunities. Visiting Scholars will meet with the Executive Associate Dean along with their faculty sponsor at the beginning of the residency to discuss their plans.

Visiting Scholars are ordinarily appointed for no more than 12 consecutive months. Requests for extensions should be made by the Scholar no less than one month before the end of the appointment (at least *three months prior to the end of the appointment* for international Visiting Scholars) and must be accompanied by (a) a detailed summary of the activities of the Scholar during the current appointment period; (b) the reason for the extension request and the research plan for the extended period; and (c) the faculty sponsor's endorsement of the request. Visiting Scholars should be aware that it is not always possible to grant extensions.

Please note that the Jacobs School of Music **does not** provide Visiting Scholars with the following:

- Salary, funds for travel, living expenses, or any other associated expenses. Any bills or fines incurred are the responsibility of the Visiting Scholar.
- Housing. It is the responsibility of the Visiting Scholar to obtain housing for the duration of the appointment.
- Performance, rehearsal, or practice spaces. Visiting Scholars are not eligible to formally reserve practice rooms or recital halls, nor are they eligible to give formally scheduled recitals.

## HOW TO APPLY

- **Domestic scholars** should submit their application *a minimum of two months* before the proposed start date.
- **International scholars** should submit their application *a minimum of eight months* before the proposed start date to allow sufficient time to complete the J-1 visa request process, which can take four to six months.

**A complete Visiting Scholar application must include the following:**

- Completed application form
- Jacobs School faculty member's signed letter of commitment to serve as a Faculty Sponsor
- A one- to two-page proposal of the work and research to be accomplished while in residence, including a specific explanation of why working at the Indiana University Jacobs School of Music is necessary to facilitate this research
- A *curriculum vitae* and detailed summary of recent research

Applications are subject to the approval of the Executive Associate Dean and the Director of Graduate Studies.

## AFTER APPROVAL

### Domestic Scholars

If the appointment is approved, the applicant will receive an official letter of invitation and a series of Indiana University Personnel Profile Forms that should be completed and submitted as soon as possible. These documents may be sent by e-mail (PDF format), fax, or mail. No other documentation will be required.

### International Scholars

If the appointment is approved, the applicant will receive an official letter of invitation and a series of Indiana University Personnel Profile Forms that should be completed and submitted as soon as possible. International applicants must also submit the following additional documentation:

- copy of passport ID page
- copy of all dependent passport ID pages (for any family members who will be coming with the Visiting Scholar)
- copy of supporting documentation showing proof of finances

These documents may be sent by e-mail (PDF format), fax, or mail.

Once the Jacobs School has approved the appointment, the School will request Visa Certification (Form DS-2019) on the Scholar's behalf to permit application for a J-1 visa (any accompanying dependents must apply for the J-2 visa). When the Scholar's DS-2019 has been issued by the Indiana University Office of International Services, an e-mail confirmation is sent that includes an International Scholar Pre-Arrival Guidebook.

International applicants should be aware that the US Department of Homeland Security (DHS) now requires the collection of a one-time SEVIS fee of US\$180 from Visiting Scholars on J-1 visas. The fee must be paid by the applicant after the DS-2019 has been issued, before the J-1 is approved; details are available on the IU Office of International Services' Website: <https://ois.iu.edu/visas/faculty-visas/j1/sevis-fee.html>

Health insurance coverage is mandatory for all international visitors and their families. Visiting Scholars are eligible for participation in IU health insurance plans and should contact International Services for information regarding enrollment; information is available on the OIS website at: <http://ois.iu.edu/living-working/health/index.shtml>

If comparable health insurance is provided by the Scholar's home institution, it will not be necessary to arrange insurance here. However, documentation in English of that insurance must be provided upon arrival on campus. This information should include the amount and extent of coverage.

## AT THE CONCLUSION OF THE APPOINTMENT

At the conclusion of their appointments Visiting Scholars are expected to submit to their faculty sponsor and to the Executive Associate Dean a concise but detailed written summary of the research and any related activities undertaken during their period of residency at the Jacobs School of Music.

**PLEASE NOTE** Before the Office of International Services can approve any J-1 visa requests, international Visiting Scholars must provide proof of financial support for the duration of the appointment (at a minimum, US\$1,200 per month for the J-1 scholar, US\$500 per month for the first J-2 dependent, and US\$300 per month for each additional J-2 dependent). This documentation does not need to be supplied with the initial application, but Visiting Scholars must be ready to submit the documentation if the appointment is approved.
